 - a. Participation in ongoing research projects at Biotox Laboratories.

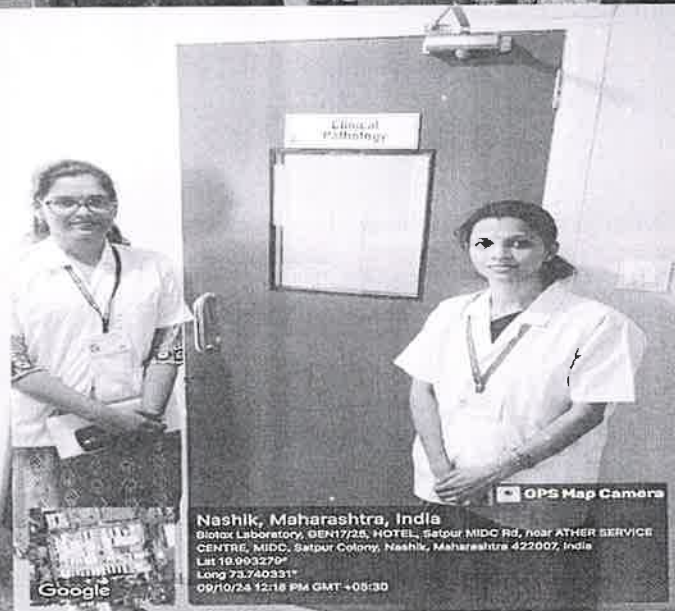
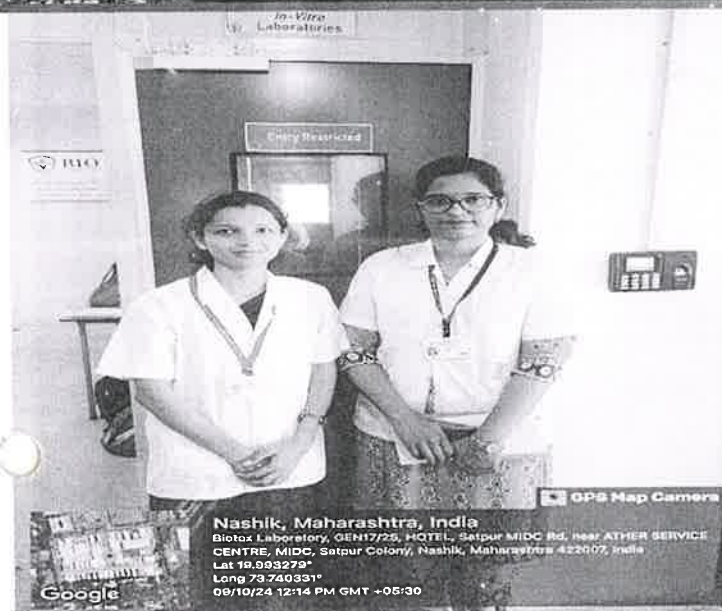
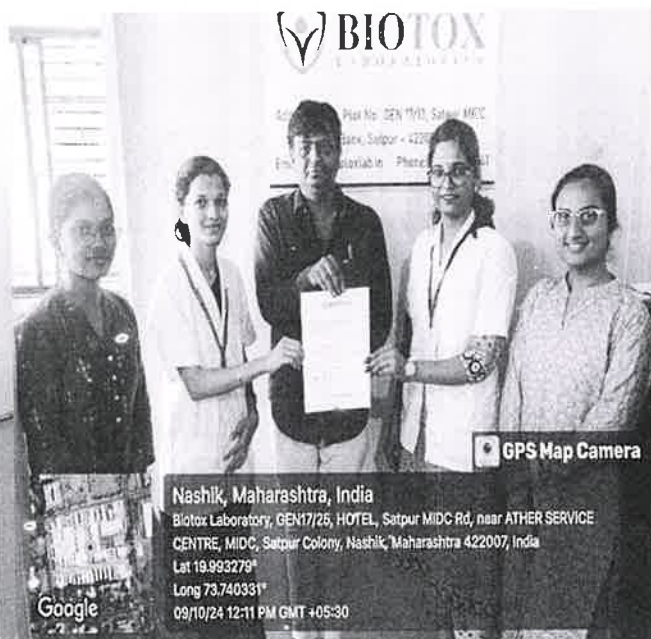
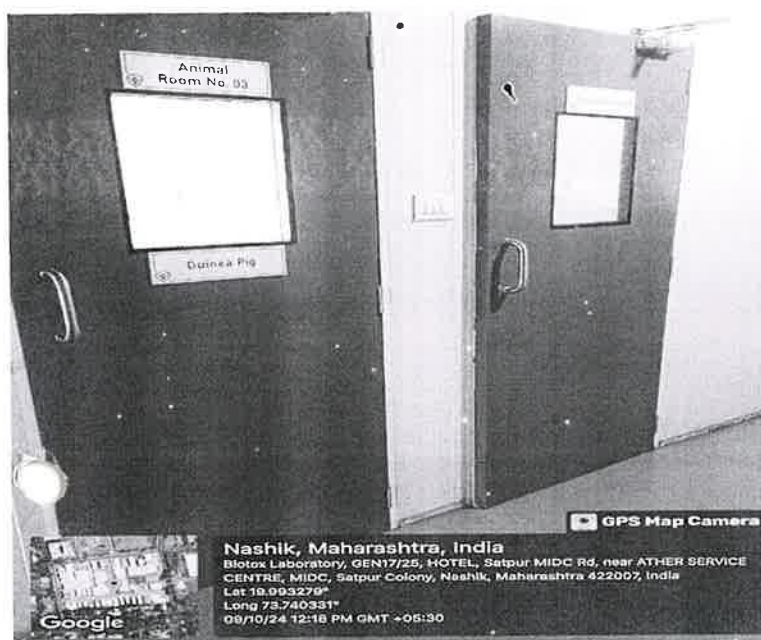
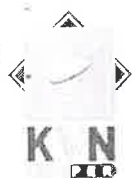
Implementation
